I conducted my weekly site inspection at Highland Estates this morning! Overall the site looks good. It is drying out from all the rain, and that has reduced the track out issue significantly. I have continued to coordinate with Bob on the stucco application for Lot 11. Sounds like he plans to schedule it for next week, as they had an inspection yesterday.

The only issue I noted this morning is that there is excessive food trash on Lot 11 that has been blowing around. I asked Bob to get that cleaned up to avoid attracting wildlife into the site and also in compliance with general housekeeping requirements of the SWPPP.
